## **PETITION TO THE EUROPEAN PARLIAMENT**

### **COMMITTEE ON PETITIONS**

We, the undersigned, Josefina Fraile Martín, consultant on rural development and public management, of Spanish nationality, D.N.I. 12.691.746 R, with address in Plaza de la Paz, 16 – 34886 Velilla del Río Carrión (Palencia) Spain, as President of the national Spanish association, Terra SOS-tenible, at the above address and Register N<sup>o</sup> 170352, and as a sovereign individual of Velilla del Río Carrión, (Palencia) Spain.

And Giulietto Chiesa, professional journalist in Italy from 1981, former member of the European Parliament, from 2004 till 2009, with address in Via Urbana 100, 00184 Rome, Italy, President of the Alternativa-political laboratory, founded in 2010 and waiting for official registration, having its address in Via Baccina 6/5 Rome, Italy

By virtue of Article 227 of the Treaty on the Functioning of the European Union, and articles 201 (Right of petition), 202 (Examination of petitions) and 203 (Notice of petitions) of the Rules of Procedure of the European Parliament, present to the Committee on Petitions this collective petition regarding:

The violation of fundamental rights of European citizens as set out in the Treaties, such as the right to health, the right to security, and the right to integrity, as well as the right to be informed. This petition also concerns environmental matters and consumer protection.

# GROUNDS

#### FIRST:

On 8th and 9th April a conference entitled **"Beyond theories of weather modification – Civil Society versus Geoengineering –** was staged in the European Parliament on the basis of a Proposal for Resolution in the Report (A4-005/99) on "the environment, security and foreign policy", adopted by the Committee on Foreign Affairs, Security and Defence Policy, the 14th January 1999, with Mrs. Maj Britt Theorin as rapporteur.

#### SECOND:

That conference was patronized by Mrs. Tatjana Zdanoka, member of the European Parliament, from The Greens | European Free Alliance and promoted by the Spanish *de Jure* association Terra SOS-tenible, Alternativa (Italian *de facto* association), and SKYGUARDS a civic European *de facto* platform, grouping different associations opposing climate modification programs (geoengineering, clandestine aerial spraying, and HAARP, ...)

#### THIRD:

In the context of the above mentioned conference a petition to the European Parliament was presented, formalized in the present document.

#### FOURTH:

The basis for this final petition is the following:

"Having regards for the seriousness of the subjects exposed in the conference and summarised in the final intervention entitled: "resume, remarks and petitions", annexed herein, and to which we refer, the main concerns of European civil society on the conference issue are:

- 1. For over a decade Europe has been subjected to massive clandestine aerosol spraying, for purposes assumed to include attempted mitigation of an officially identified global warming/climate change problem and/or facilitation of the operations of HAARP (High Frequency Active Auroral Research Project) and HAARP-related activities such as those of MUOS in Sicily.
- 2. These actions are being implemented outside of any legal framework, national or international, without the knowledge or informed consent of the population, and in violation of the most elementary precautionary principles.
- 3. The consequences of these actions for peoples' health and life on the planet are incalculable;
- 4. National governments, which have the duty of authorizing the use of national airspace, deny that these actions are taking place.
- 5. Institutionalized denial of obvious facts that violate fundamental human rights (the right to health, to security, to physical and psychical integrity) leaves citizens totally defenceless.

#### FIFTH:

# On the basis of the preceding statements, effective protection of European civil society was demanded of the European Parliament.

#### SIXTH:

**On the other hand,** given that the European Parliament has at its disposal the juridical instrument of the extraordinary parliamentary investigative committee, we demand (1) that this essential instrument be employed without any further delay, (2) that the present proposal be taken to the Presidency of the European Parliament to be examined, (3) that a public debate be opened with participation from civil society, and with retention of the present platform as a contribution to the evidence and as proof of what is happening.

#### SEVENTH:

Lastly, a demand is submitted full implementation of the Proposal for Resolution "On the Environment, Security and Foreign Policy" cited in the FIRST paragraph. Quoting among others, that a Green Paper be elaborated on military activities affecting the environment; that secrecy in military research be resisted and openness and democratic scrutiny of military research projects encouraged; and that civil laws on the environment be applied in relation to all military activity.

# **LEGAL GROUNDS**

- Charter of fundamental rights of the European Union, adopted on 2000.
   Article 3 Right to the integrity of the person 1. Everyone has the right to respect for his or her physical and mental integrity.2. Article 6 Right to liberty and security Everyone has the right to liberty and security of person. Article 37- Environmental protection must be integrated into the policies of the Union and ensured in accordance with the principle of sustainable development.
- 2. Directive 2001/42/EC of the European Parliament and of the Council of 27 June 2001 on the assessment of the effects of certain plans and programmes on the environment stipulates that an environmental assessment is carried out of certain plans and programmes which are likely to have significant effects on the environment.
- 3. The UNECE Aarhus Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters, adopted on 1998 links environmental rights and human rights; acknowledges that we owe an obligation to future generations; establishes that sustainable development can be achieved only through the involvement of all stakeholders. The Convention links government accountability and environmental protection, focusing on interactions between the public and public authorities in a democratic context.
- 4. The Universal Declaration of Human Rights, adopted by the UN in 1948. Article 3. - Everyone has the right to life, liberty and security of person. Article 6.
  - Everyone has the right to recognition everywhere as a person before the law. Article 8 - Everyone has the right to an effective remedy from the competent national tribunals for acts violating the fundamental rights granted him by the constitution or by law.
- 5. Convention on the prohibition of military or any hostile use of environmental modification techniques, adopted in 1976.
- 6. UN Nagoya Convention on Biological Diversity, 2010, establishing a ban on some forms of geoengineering.

## Therefore,

We demand that this petition (and the annexed documents), be admitted and, given the seriousness of the facts reported in paragraph FOUR, that the Committee on Petitions grant the demands submitted by us in the Conference summary, and in paragraphs FIVE, SIX AND SEVEN of the GROUNDS for this petition. <u>And HAVING REGARDS</u> that weather modification programs / geoengineering are an accomplished fact in <u>Europe</u>, we appeal to the European Parliament for thorough investigation to be made at all levels, including analysis of soil, water, air, flora, fauna, persons and animals, by independent experts, for the purpose of compiling evidence for legal action against those responsible for these actions against public health and security, and those aiding and abetting them.

For the purpose of making this petition effective, we sign it, in Velilla del Río Carrión, the 10th April 2013, with our signatures heading this collective petition.
